**Officer Jim Lopez**

Officer Lopez spoke to us about becoming a neighborhood watch member. Since the police do not monitor next door, they need help pushing out information. They are offering a Crime prevention presentation for District 3 which includes how to become better engaged. This is scheduled for the first week in November.

Otherwise he is willing to do a presentation to our group some time in early 2019.

Jack – we participated in neighborhood watch when we were in District 4. One of the concerns was having to inventory all of your possessions. Can we use cell phones for inventory? Jim explained that it is not required to take inventory but always recommended. They are just looking for anyone who would be willing to help in the neighborhood watch.

Amy – as part of training do you cover things like warning signs vs profiling? You are taught to recognize when something looks bad, then it probably is. Behavior is suspicious whereas People are not suspicious. Rob – Asked about whether there is any signage? Is there designated watch area? If so, how is it defined? We can have signs if we want but don't need to. The main thing is to be aware. No hiding in houses. Just be engaged with your neighborhood, know your neighbors. If

you See something – Say something.

Rob – Asked whether there was any feedback on the Grandoozy festival and how was it received? Officer Lopez said that he heard that it went really well where only a few people went to detox. No real problems and actually was the easiest thing they ever worked with no reported crime during that time.

### **Presentation from [Healthy Food For Denver Kids](#)**

Blake Angelo has been working for many years with volunteers and the city on the initiative for planting in the city and growing fresh food in the parks. In the past 10 years 50,000 lbs of fresh food was routed to the most in need. Still, within the last 30 days, 1 in 7 Denver kids missed a meal because their families couldn't afford to eat. The Healthy Food for Denver campaign is speaking up for them by working to provide 3 nutritious meals a day along with cooking, gardening, and nutrition education.

It would create a 13 person commission (The Denver Food Commission) that would hold the responsibility of granting out the money in one-year grants. Page 6 Section 2-242 talks a bit more about the Denver Food Commission and Page 7 Section 2-243 describes some of the criteria for organizations eligible to receive the grants. Look for this on the ballot next month.

OPNA received a sponsorship of \$100 from Healthy Food to be used for our potluck next month.

**Brenna** works with Beth McCann who serves as the current Denver District Attorney. Beth is sending someone to each neighborhood meeting to provide questions and answers and report any trends happening in each area. Currently property crimes are the main type of crime in our area. **Maggie** - Broadway Halloween Parade. Maggie expanded on the details of the parade where the feedback from last year was that it was neighborhoody and funky and enjoyed by people in the parade and all those watching the parade. This year it will start at 6pm and travel from 5th Avenue south to Alameda on Broadway. Floats will gather in the Denver Health parking lot. All car parking will be at Alameda and Broadway at the Broadway Marketplace where people will be shuttled to the starting place. It is really Fun for all ages.

**Jolon** – The 2019 city budget 2019 is now available on line found [here](#) which includes all departments and agencies. Some highlights include – increase for mobility, pedestrian crossing, a new dog park in south Denver, affordable housing, marijuana revenue and spending and more. Best to open the PDF and search for topics of interest.

Green roof initiative –has been in review for the past 6 months, after which can repeal – super majority – task force to look at it. What is it? 40 members. 30 hours of meetings – recommendations of changes. Multiple paths to compliance – easier to be in compliance. Eliminates exceptions. Now need to be voted on city council.

Mayor – committed to 100% renewable energy. How to do this? Council will be working on that.

Parks system is under funded. 28 million \$ gap for replacing existing parks and playgrounds. Where we used to be 7th in the nation ranked for parks. In 2018 dropped to 26th. If you don't vote on this they may need to shut down parks.

**Rob** – expressed the need for more people to carry the load and proposed adding a community outreach coordinator position where the duties would include working to grow the membership, outreach to businesses, updating social media, marketing, etc. Jack made a motion to add the position where Mara seconded and it was approved.

Amy asked the group to fill out post-it notes to gather feedback related to the Grandoozy festival. The group was asked to identify what went well? and what were some areas of opportunities? **David Ehrlich**, the local rep for Grandoozy and Supefly gave a BIG Thank YOU!! to OPNA. He has enjoyed working with our neighborhood and realizes that Councilman Jolon Clark took a gigantic risk when he agreed to move forward with the proposal almost 2 years ago. He appreciated that we created an atmosphere where we were open to the idea, took the time to listen and learn and most of all to provide good feedback all along the way which helped to guarantee the success of the festival. He will continue to work with us as this is a learning process of everyone. They were happy with the large audience and all the diversity of the concert goers where the largest group was in the 23-24 age group. The main comment has been that everyone seemed so happy.

What's next? The return of the golf course where they are working with a 3rd party

damage consultant. They found that there wasn't much damage where it has mostly required some re-sodding, aeration and seeding in some of the areas. He pointed out that the yellowish grass in some areas is due to the current drought condition which was not caused by the festival. They are tracking to reopen on October 8<sup>th</sup>.

Next up is working with the accountability committee to formalize the feedback which will be delivered to the Mayor. He noted that the biggest challenge was with egress through the neighborhood and ride share drop off and pick up throughout the weekend. Also, he will be meeting with neighborhood representatives regarding how to reinvest into the neighborhood.

Andrew – asked of the breakdown of ticket sales? Mostly local and a little older than expected. Although they are able to scale up to 80,000, current trends in the market don't lend to that.

Jack – Asked whether lowering the expectations would lower the acts? Actually they feel that they want to add slots for more acts.

Amy – asked about any shift layout, i.e. it was hard to get into 80s ski lodge, and shade would be nice over break room? They underestimated how many people would enjoy these areas and are taking all comments into consideration for future. Also, saw the need for more more lighting.
