### Jewell Pedestrian Bridge Update Gabriella

Gabby from public works provided the following updates on the Jewell Pedestrian Bridge which was approved last year as part of the GoBond program. Since the approval, more development has happened in this area. The bridge landing that was planned for on the east side of Santa Fe was built out with the new apartment

complex so can not be utilized. As an alternative there is a small parcel of land owned by the railroads that could be used as an easement. On the west side of Santa Fe, the landing would be either on the Golf course, or the parcel of land south of Jewell Ave which is currently owned by RTD.

She presented a conceptual architectural alignment rendering where the bridge will need to be at least 27 feet high to go up and over the trains. The span needs to be 600 feet to reach from east to west which would be the longest in Denver, 5 feet less than the bridge span over Colorado Blvd! Once they have finalized the bridge conceptual design, the next step is to complete the engineering design where they should have a RFQ by the end of this year. Once they have selected the engineering consultant, the engineering design can take up to two years. Some questions asked.

Andrew - The 2 sides of the bridge span shows circling paths down to landing area. Why not an elevator? They don't do elevators anymore due to the maintenance challenge but there would be stairs as an option.

Amy - what is the possibility of buying land parcels for the landing area and could they use 2A money? No. The rail company is not selling the piece of land on the East side and buying land is too expensive.

Judy - can we write a letter of support? Not yet but we will be notified when the time is right.

Gabby also reminded everyone that if you see anything on the streets which need repair, including traffic signals please call 311. You can contact 311 by phone on on their web page. City is trying to track everything using this system.
