### Presentation by Alan Polonsky - Environmental Quality Division

Alan gave a brief talk about the department he works in for the <u>water quality</u> <u>program</u> which includes training, water sampling of Denver lakes and rivers. He handed out a flyer specific to our own Overland Pond which is the only lake fed directly by the South Platte River. He told us that July is lake appreciation month and is looking to do something at Overland Pond. Maybe cleanup around the pond, have some educational program and boats to take out on the pond. Ronnie will coordinate with Alan and bring back information to the neighborhood.

# **Overland Pond**

#### Background, Long Term Issues & Trends

- Overland Pond receives high nutrient concentrations from its source water (South Platte River ) which results in excessive algae growth, primarily in the form of <u>phytoploxitton</u> (small floating algae).
- The high algae growth contributes to poor water quality and clarity and potentially physically stressful conditions for aquatic life (elevated pH).

#### **Developing Issues**

The pond was renovated in 2013 through a project coordinated by the Greenway Foundation. The renovation included sediment removal, re-grading of the pond bottom, and reconstruction of the pier, amphitheater, and boat access.

Based on 2013 and 2014 monitoring results, the renovation may have initially contributed to improved water quality. However, depth measurements in 2014 suggest there was considerable in-fill of the newly created holes. The September 2013 flood events may have contributed to sediment deposition, which would account for that.

The outlet structure was replaced in November 2014 (see photo) with a flow through system which will assure consistent water movement through the pond (when its full). Improved conditions noted in 2015 (significantly lower phytoplankton activity, improved water clarity, lower pH and organic nitrogen levels—see figure below) may have been a result of increased water exchange.

The pump facility that diverts water from the South Platte River to Overland was to be replaced in 2015. This should not impact the source water quality.

#### Fish, Wildlife, & Habitat


Fish: Over the past few years, Overland has been stocked with a variety of fish including bluegill, bass, catfish, and tro (the latter to support youth fishing events). While Overland Pond can sustain a healthy warm water fish community, it is marginally suitable for trout. The frequently elevated pH, warmer temperatures, and variable oxygen are often at levels will physically stress trout.

WildBfe: Although the park is limited in size, when combined with the adjacent South Platte River corridor there is go habitat provision for wildlife and birds. Kinglishers, herons, and a variety of waterfowl are common visitors at the pond.

Hobitot. Thanks to efforts by the Denver Department of Parks & Recreation, and the Greenway Foundation, Overland and the park have developed into an ideal natural area with quality wildlife habitat. It also serves as an environmental c room for a variety of ages, and provides good recreational opportunities (fishing, wildlife viewing). The recently installed structures and pier supports provide some habitat structure for aquatic life.

#### Recommendations

- Sustain healthy aquatic life structure by maintaining bank-full conditions.
- Enhance naturalized areas by connecting with AquaGolf and the South Platte River corridor.
- Continue stocking of predatory fish (bass) to enhance the <u>zoo-</u> <u>plankton</u> community which will feed on phytoplankton.
- Test non-chemical algae control alternatives such as ultrasonic waves and barley straw to control annual phytoplankton blooms and subsequently stabilize pH.

Then he opened up for questions.

Jack – goose poop and whether there is any effect? Geese were almost extinct in 1940s but are now very abundant. Goose poop may contribute to increased ecoli in the water but the main offenders include leaking infrastructure and the waste water treatment plant up river. The biggest challenge is to keep the ph level down.

Terry - Asked about the safety of tubing in the river? If you have any open cuts or are overly sensitive, then it is not recommended as there could be higher levels of bacteria. Do not drink any of the water and always wash your hands after contact. Having said that, Alan said he is planning to join the tubing party. Rob – How does the golf course impact the river and lakes and would there be any additional impact related to having a Music Festival for 3 days? There is no water leaving the golf course and the pesticides and fertilizer which is used is applied appropriately so it's ok. Also, they have certified appliers who spray for weeds where his department makes sure they are doing it right. The pond on the golf course belongs to them and they are responsible for that. Regarding the festival, as long as there are enough bathrooms he sees no issue.

### David Ehrlich Update on Overland Music Festival

David gave an update on the progress of the music festival where they met with the Denver City Council Land Use Transportation and Infrastructure (LUTI) to discuss the contract which is in process. David thanked everyone for coming out to support the festival. The committee meeting went well and very positive. Where there are still some people against the festival, David is still open to sit with anyone to discuss any issues which should be considered and addressed. They are now putting more detail together on the non-profit component where they are planning to put together an advisory board which will include 3 representatives from Overland Park, 1 from Ruby Hill and 1 from Athmar park. Each community will need to decide on the representatives where the group will provide input as to where the money which comes into the neighborhood will go including non-profit and operational

Paul – Please explain the ticket pricing? 1 dollar for every ticket sold will come directly back to the neighborhood. Even comp tickets will include a charge that goes directly to the non-profit component of the payout which includes a sum which will go to Levitt Pavilion. The advisory board will decide what funds go where which can be small amounts towards many projects, or using the money to kick start a larger project.

Jack – Asked about what comes next regarding city council. Councilman Kashmann, in the last meeting, expressed that he wants to parse the contract

before it is in it's final submission scheduled for July 10<sup>th</sup>. They are working on getting the contract to city council a week before the 10<sup>th</sup> but if there is not enough time, the public hearing may happen on the 10<sup>th</sup>, with the final vote maybe on 17<sup>th</sup>.

Paul – Asked about the contract and plans that affect us and how do they plan to improve going forward. There will be a an informal group which will participate in process improvement process every year. This was recommended by the Mayor as a way to insure the communication continues to remain open and any new issues which arise will be addressed appropriately.
