Police Report

Officer Sharon reported that for the past month, overall crime is down 57% in all categories. Even burglary is down by 1! The highest concern right now is in the RTD area including car thefts. Also Broadway and Iowa area where transients congregate and drug dealings occur. Jack – asked about

the new commander. She is busy but will have commander's meeting on Sept 1st 6pm at District 3 office. Starting October, meetings will be on first Monday of the month, 6pm.

Fitness Zone at Pasquinel's landing- Chandi Aldena

Chandi from The Trust for Public Lands presented information regarding the planned fitness zone at Pasquinel's Landing. It will be located right off the trail as it is looping thru the park. The fitness zone is similar to what you find in a rec center or gym, where all pieces of equipment are in one location. They are permanent structures, built for outdoor usage. She presented us with 20+ choices of equipment where we were all able to vote for the top 5. A quick tally of top 5 included Elliptical machine, chest press, lat pulldown and captain's chair. She will take this information back to be used in the final decision. The installation will follow after the construction is complete where Denver parks and rec will prep the site.

Mara – asked Why a fitness zone? There has been funding provided for fitness zones in other existing parks throughout Denver. With the reconstruction of Pasquinel's landing, this became a prime candidate to be included in the park since Denver parks and rec had already planned for an adult fitness area.

Update on Construction schedule/Grand Frontier/River

Michael Bouchard was unable to attend the meeting but has agreed to be at the next OPNA meeting in September. He provided a written update regarding the projects in our area and requests any questions or feedback returned to him thru Mara. See bottom of the minutes for details.

Jolon Clark's Office (Council District 7) Maggie Thompson

Update from Maggie included the following:

1 – Jolon along with the city forester visited a few cities in the mid-west to meetand discuss how they have been dealing with the Emerald Ash borer disease which has started to affect Denver. Information gathered will be provided including education and treatment of this disease.
Denie – asked whether assistance would be offered to lower income and elderly for tree mitigation. The council is working to get this into the budget for treatment and tree removal. There will be a website created which will provide more information. They are also looking for ways for neighborhoods to inventory the trees in their areas.

2 – Jolon will be travelling to Amsterdam next week for the Greenlands Project – People for Bikes (<u>http://www.peopleforbikes.org</u>). They will be meeting with decision makers to learn more about bike facilities and will bring back info.

3 – September 25-27. Bikes on Broadway is planning a demonstration / feasibility study to connect 6th Ave down to Alameda. There will be a 2 direction bike lane on the East side of

Broadway. On Saturday, Sept 26th – merchants will activate in support. Come out and ride and support this fun event.

4 – There is a new landowner of the Shaddock site where there is talk of some 200 housing units planned for development. The city council is working on communicating with them regarding the landing site for the Jewell Ave. pedestrian bridge which is currently on their property. They will reach out to them and invite them to come and present at our OPNA meeting in the future. Peter – has also been in contact with Robin Kniech regarding this as she is also an important city representative for our neighborhood.

Mara – asked for a status update of the new lights and crosswalk signs scheduled to be installed on Evans Bridge? Maggie will provide update for next meeting.

Broadway I-25 Station Area Plan update

Mara is our delegate and is gathering ideas. They are looking for input from everyone, not just the delegates. Connectivity is the big topic where they are hoping to create a "Midtown" area, not just a transportation hub. It would be more of a destination area with mixed uses of retail and medium to light industrial. **The next meeting is Tues Sept 1st – 5:30-7:30pm - Working group. River Vision Update: (Michael Bouchard, Denver Parks and Rec)

Schedule B – Overland River Reach

Now that the water has finally receded, our contractor, Naranjo, is completing the last main piece of construction, Riffle 5, just south of Jewel. They will complete this by the end of next week.

They will also be repairing the damage from the sustained high water. This includes:

- Rebuilding the wetland benches
- Regrading the eroded banks
- Adding concrete ramps at Jetty 1 and 2 up to the 10-yr flood elevation
- Grouting the boulder walls at the Overlooks to prevent further trail erosion

Also along this stretch, but by a different contractor we have nearly completed:

- Planted (65) cottonwood and willow trees
- Planted (67) assorted native shrubs
- Installed dedicated irrigation zones for the new plant material
- Repaired existing irrigation zones for native grass areas
- Right now they are finishing up regrading the trail and disturbed native areas
- We are waiting until later in the fall to re-seed and hydromulch this stretch

Schedule C – Pasquinel's Landing

ECI is the contractor. So far they have:

- Completed 75% of the island and secondary channel
- 100% of the boulder wall and gravel bar at the bottom of the lawn
- They've built the concrete crossings to the island
- They've started installing the trail on the island

Over the next month they will:

- Construct the riffle at the upstream end of the secondary channel
- Connect the downstream end of the secondary channel to the river
- Begin removing their sheet-pile cofferdam
- Begin working up from the river on the trails, boulder walls, irrigation and planting areas

We anticipate completion by the end of 2015

Schedule D – Grant Frontier

ECI is the contractor. They will not begin full-fledged construction until early October. The playground has been removed, fencing has been put up and there are 2 big holes in the ground.

- Ruby Hill MT bike course has started construction in the SW corner of the Park
- Their design requires about 10,000 CY of fill material to create the topography
- We worked out a deal between the two projects to bring extra material from Grant up to Ruby

Combined savings for both parks is over \$100,000
