This would be used in response to the recent thefts in pot shops. It is not intended for any type of profiling. It is only used to record the LP where later the data is purged. No comments or objections from the group.

Mara Shapiro - Govotecolorado.com Register to Vote – working in precinct 232 where she is pushing to get everyone to vote. Please pass the word if you know someone, especially in the new townhomes and duplexes. She explained that in Colorado you can register to vote up until the day of the election and if you go in person, can register right there. If you want to do mail in, you will need more time. You need to be a US citizen, 18 years or older to register and some proof of your current address (driver's license, utility bill, etc.) Go to Govotecolorado.com and look up your registration and get any other information needed to vote.

Sara White, Development Project Manager - Evans Station Area project

<u>Palisades Partners</u> is a small local development company that are looking at projects in the Evans Station Area project. Currently involved with 2 projects. They are excited with the potential in this area and especially with the upcoming Jewell pedestrian bridge where they are looking for ways to activate in this area. They are asking for any input to these projects where they plan to build and then maintain the properties.

- 1 Closed on property at corner of Acoma and Jewell which is already zoned appropriately. Plan to locate their permanent office space.
- 2 Currently under contract property at corner of Jewell and Bannock which is currently zoned as industrial and would like to rezone to mix used.

They have submitted the pre-application for re-zoning for 5 story mixed use including housing and retail. Some things brought up for ideas included groceries, affordable housing options, good neighbor agreement, community involvement, scholarship. Pass along any other comments to them through their website.

Presentation from Tobacco-Free Kids – Bethany Gravell

Bethany gave a presentation on a proposed ban on flavored tobacco products. There has been a explosion of flavored tobacco products where the sales of these products often is targeted to young people, leading to addiction. The latest CDC data shows the youth e-cigarette epidemic is getting worse. Now, 5.3 million U.S. kids are using e-cigs. An overwhelming majority of them say flavors are why. And Colorado's youth e-

cigarette rate is among the highest in the country. We must end the sale of flavored ecigarettes and all other flavored tobacco products. This includes menthol cigarettes and flavored cigars – which the tobacco industry uses to target and addict youth, especially in communities of color.

The campaign has been reaching out to organizations and RNO's for endorsements where they are close to reaching 50. They will then send to the Mayor. A motion was made for OPNA to support with a letter now. The vote was unanimous for the group. More information can found on this website FlavorsHookKidsDenver.org

- o Jewell bridge still continuing to move even though the city budget has been crushed by covid. Because this project is bond based, it is insulated from that and still moving forward.
- o lowa underpass city broke it into 2 parts path and golf course separately funded. The current project manager thinks they found the funds for both parts which will make the project whole again.... First contract for \$\$\$ came thru city council last week. Timeline to come soon.
- Please take the Travel survey available on District 7 <u>Facebook</u>,
- o Census a few more weeks. Very important 65% for Overland. Need full count for better representation. Also affects federal allocation of money back to CO. Please fill it out which only takes a few minutes.
- o Register to vote please vote the whole ballot. Drop it early.
- o Mayor dropped the city budget for 2021 with the worst cuts since 1923 due to covid. Speaking of which, we are now in the 3rd spike with covid where it is still not levelling off yet. Good news is that although cases are spiking, number of hospitalizations have significantly levelled off. Most days 0 people die. Here's a useful link to COVID-19 information in Denver.

US 85 Denver Resurfacing


TRAVEL ADVISORY

Motorists can expect ramp closures from Santa Fe Drive to the Evans Avenue bridge beginning after L Day. The ramp closures are a part of the US 85 Santa Fe Resurfacing project and will allow crews to efficiently replace damaged concrete panels, bridge expansion joints, and curb ramps. The ramps muremain closed 24/7 during the timeframes listed because the asphalt will be removed, and expansion joints will be replaced. Thus, the nature of the work does not allow for the traffic to safely travel ov the ramps.

RAMP CLOSURE SCHEDULE

Each ramp mentioned below will be closed 24/7 during the timeframes listed:

- Northwest Evans
 Avenue bridge
 ramp closure will
 take place Sept. 8
 through Sept. 21
- Southwest Evans
 Avenue bridge
 ramp closure will
 take place Sept. 22
 through Oct. 5
- Southeast Evans
 Avenue bridge
 ramp closure will
 take place Oct. 6
 through Oct. 19





Northeast Evans Avenue bridge ramp closure will take place Oct. 20 through Nov. 2

DETOUR ROUTE & IMPACTS

- 24/7 ramp closures will occur on the ramps from Santa Fe Drive to Evans Avenue.
- Traffic will be <u>detoured</u> to Iowa and Dartmouth Avenues, then to Broadway to get onto Evans
- Evans Ave will encounter intermittent single lane closures near the closed Santa Fe Drive ram
- Motorists may encounter reduced speeds within the project limits.
- Traffic fines will be doubled in the work zone. Motorists should slow down as they approach the
 work zones, drive with caution, allow extra space between vehicles, and give themselves extra
 travel time.
